

# Resolution Licence Agreement

## **GENERAL TERMS**

The expression "software" means the computer program stored on the CD-ROM or disk. "Software materials" means the CD-ROM or disk containing the software and accompanying manual. The software is protected by copyright. You agree that the software and software materials are for business purposes only and your purchase is not governed by the Consumers Guarantee Act 1993. AgResearch Limited is the owner of the software (hereafter referred to as the Owner). Sales and service are undertaken by the Owner. The purchase price covers the software materials and includes a non-exclusive licence with the following terms:

You may:

- copy the software onto a computer to be used;
- make one backup copy of the software for the sole purpose of protecting your investment;
- allow the software to be used by your staff or family.

You may not:

- load the program onto more than one computer;
- reproduce all or any of the software except for a single backup copy mentioned above;
- sell, rent or lease the software or the software material;
- reverse engineer, decompile, disassemble or create derivative works from the software, unless you have signed a third party agreement with the Owner.

## **LIMITED WARRANTY**

The Owner warrants for 90 days from the date of purchase (as evidenced by a copy of your receipt) that

1. the software, unless modified by you, will perform substantially the functions described in the documentation provided by the Owner and
2. the CD-ROM or disk on which the software is provided will be free from defects in materials and workmanship under normal use. Your sole remedy under this warranty is that the Owner will undertake to correct within a reasonable period of time any reported "software error" (failure of the software to perform the functions described in the documentation), correct errors in the documentation, and replace any diskette which proves defective in materials or workmanship on an exchange basis without charge. To make a claim under this warranty you must return the defective item with your receipt to the Owner. If the Owner is unable to replace any defective CD-ROM or disk or to provide corrected material within a reasonable time, your purchase and licence fee will be refunded. These are your sole and exclusive remedies for any breach of this limited warranty.

The Owner does not warrant that the software will meet your requirements, that software operation will be uninterrupted or error-free, or that all software errors will be corrected. The Owner has no responsibility to replace or refund the purchase and licence fee for any CD-ROM or disk damaged by accident, abuse or misapplication.

## **LIMITATION OF LIABILITY**

The Owner shall not be liable to you for any direct or indirect loss (including lost profits, lost savings, or other incidental or consequential damages), arising in connection with this licence, the software or its uses. The entire liability and remedy for breach of the limited warranty shall be limited to either replacement of defective CDROMs, diskettes or documentation, or a once only refund of the purchase and licence fee

## **TERM OF LICENCE AND BREACH**

The term of this licence is for the term of copyright in the software. If you breach any of the terms of this licence your licence is automatically revoked and the Owner will require you either to return or destroy the software materials and all copies of all or any part of the software or software material without compensation to you and without prejudice to any other remedies available under law to the Owner.
